



## **NOTICE OF ELECTION AND POLL, NOMINATION OF CANDIDATES AND CLOSING DATE FOR NOMINATIONS FOR THE 2025 ELECTIONS OF TARANAKI REGIONAL COUNCIL**

**Under sections 52 and 53 of the Local Electoral Act 2001, I give notice that on Saturday 11 October 2025 the following elections and poll will be held by postal vote using the First Past the Post electoral system:**

### **ELECTIONS**

#### **Constituency**

Election of five councillors for the New Plymouth General Constituency

Election of two councillors for the North Taranaki General Constituency

Election of two councillors for the South Taranaki General Constituency

Election of one councillor for the Stratford General Constituency

Election of one councillor for the Taranaki Māori Constituency

Candidate names will be listed in alphabetical order on the voting documents.

### **POLL**

The Taranaki Regional Council is required to hold a poll on Māori constituencies with the 2025 elections.

The outcome of the poll will be binding and apply for the 2028 and 2031 triennial elections.

The poll is a vote to KEEP or REMOVE Taranaki Regional Council's Māori constituency.

### **NOMINATIONS**

Each candidate must be nominated on the appropriate nomination paper. Candidates can complete and submit their nomination online at **[esp.electionservices.co.nz/lge2025/TRC](https://esp.electionservices.co.nz/lge2025/TRC)**

Nominations of candidates must be submitted online or in the hands of the electoral officer or an electoral official no later than midday on Friday 1 August 2025.

Each nomination must be accompanied by a deposit of \$200 GST inclusive (payable by bank transfer, eftpos or cash). Online nominations require proof of the deposit to be uploaded as part of the submission.

A candidate may submit a candidate profile statement and photo with their nomination paper. All nomination material must be submitted together. Any candidate profile statement or photo will be included with the voting documents and sent out to electors.

An attachment to the nomination paper outlines rules and procedures governing candidate profile statements. The same information also appears in the online nominations portal.
