#### **Document Circulation**

Pursuant to section 41B of the Resource Management Act 1991, the Council requires the applicant's briefs of all evidence to be pre-circulated. Similarly, submitters intending to call expert evidence are required to provide the evidence prior to the hearing. The timeframes for provision of those briefs are as follows:

**Applicant's Evidence:** 28 January 2022 **Submitter's Expert Evidence:** 4 February 2022

The applicant's experts may respond to any submitter evidence, in which case such responses shall be provided by 4.00 pm 11 February 2022.

The briefs must be forwarded electronically to consents@trc.govt.nz by the dates listed above. This information will be then be made available via the Councils website at: https://www.trc.govt.nz/environment/resource-consents/notified-consents the next working day.

Copies of the Taranaki Regional Council officer report will be available in the same location on the Council's website by 24 January 2022.

#### **Hearing Procedure**

While the procedure for the hearing is ultimately determined by the chairperson, the Resource Management Act provides that:

- a) unnecessary formality is to be avoided;
- b) only members of the hearing panel may question any party or witness
- c) cross-examination is not allowed.

### **Hearing information**

- Expert evidence is not be read verbatim at the hearing but may be summarised in a "highlights package".
- Non-expert evidence original submissions lodged on the applications will not be read
  out at the hearing but may be expanded on. The Commissioners will read all
  submissions and pre exchanged evidence prior to the commencement of the hearing
  and any other evidence during the hearing.
- 20 hard copies of any written information presented by non-expert speakers or their representatives (who are not expert witnesses) shall be made available to the Senior Consents Administration prior to the commencement of the hearing (or as soon as available after your arrival).
- The Council will send you a copy of the agenda/order of proceedings before the hearing.
- Tea/Coffee will be provided.

#### **Covid Impacts**

Covid-19 restrictions may apply and zoom facilities for the hearing may be required. The hearing venue policies around Covid will apply and be circulated with the hearing agenda.

#### **Judicial Review**

Arising from the resolution of a judicial review it was agreed that land owners of properties within 400 metres of the chicken farm (including New Plymouth District Council) can become additional participants for the hearing and participate (refer to the judicial agreement for any details). Details on those who want to be part of proceedings has been requested from the judicial review parties lawyer. In the absence of a response and wanting to give parties early notification of the hearing, a decision has been made to notify the hearing to all the parties within 400 metres of the farm. Early informal feedback was only those parties to the judicial review were interested in appearing at the hearing.
