Trustpower propose to operate machinery within the bed of the Waiwhakaiho River (at / within the fish pass structure located on the true right side of the diversion weir), for the purposes of regular maintenance of the diversion weir and fish pass. The machinery will be utilised to disturb / extract gravel from the bed of the river, and to remove boulders, debris and small rocks after high flow events.

Materials that are removed will be placed on the true-right bank of the Waiwhakaiho River.
