aware of the changes that have occurred in the lake, even in the past 12 months.

The lake is a focal point for many of the residents of Opunake and is a draw card for many visitors. It has quite a history, and the information boards around its perimeter show pictures of recreational use over many decades.

It has been used for swimming, boating, water skiing, jet skiing, kayaking, wind surfing and fishing and provides a safer environment for many of these activities than the nearby ocean beaches.

The Opunake Loop track, South Taranaki's longest formal path circumnavigates the lake and the lake itself is a highlight of this

walk. Camping is popular on the western shore and the lake is an attraction for local and international tourists.

However, sedimentation in the lake has considerably reduced its depth, reducing the suitability for water based activities. As such, the use of the lake for these activities has declined over recent years.

The shallower waters have also encouraged the growth of vegetation in the shallower water on the lake's perimeter, and weed throughout, clogging the water and further restricting its suitability for recreational use.

The bird life that is present in numbers (black swans, Canada geese, and ducks) tend to favour the deeper water at the western end of the lake, rather than the shallower eastern end.

Allowing water heavily laden with silt and sediment during flood and high water flows from the Waiaua River into Opunake Lake would hasten the sedimentation and vegetation of the lake, rendering it unsuitable for any recreational activities, and quite possibly the attraction for some of the birdlife already present.
