Land Use Consent Information Memorandum-Uruti Composting Site

The Uruti Composting/Vermicast Facility (UCF) is currently operating as a consented commercial composting and vermicast business, which processes organic material into compost and vermicast. The composting operation is owned by Remediation (NZ) Ltd.

The composting facility at Uruti is a large contributor to minimising the Taranaki region waste disposal to landfill.

This site currently operates under Resource Consents issued by the Taranaki Regional Council. Two of the consents expire on 1 June 2018 and we are in the process of applying for renewal. The consents are 5838-2.2 which is to discharge a) waste material to land for composting and b) treated stormwater and leachate from composting operations; onto and into land in circumstances where contaminants may enter water in the Haehanga Stream catchment and directly into an unnamed tributary of the Haehanga Stream and consent no. 5839-2 which is to discharge emissions into the air, namely odour and dust, from composting operations. The composting part of the operation involves composting of greenwaste and other approved inputs, and has been able to operate with only minor effects.

I have attached a copy of the existing consents that are the basis of which we will be applying for renewal.

As part of this process we are asking you as the land owner/occupier to either agree with our proposal for continuing the operation, or if you have any particular concerns how we may resolve these to our mutual satisfaction.
