Executive summary

Waverley Sawmills Ltd (the Company) operates a wood waste disposal site located on Monk Road at Waverley, in the Whenuakura catchment, and a former wood waste disposal site located on Village Settlement Road at Waverley, in the Moumahaki catchment. The Monk Road site is consented to receive untreated wood waste only, and the Village Settlement Road site is consented to receive treated and untreated wood waste. All the wood waste discharged at both sites originates from the Company's sawmill in Waverley. This report for the period July 2017 to June 2018 describes the monitoring programme implemented by the Taranaki Regional Council (the Council) to assess the Company's environmental and consent compliance performance during the period under review. The report details the results of the monitoring undertaken and assesses the environmental effects of the Company's activities. This is the eleventh compliance monitoring report on the Company's activities at the Monk Road and Village Settlement Road sites.

The Company holds four resource consents relating to its wood waste disposal sites, which include a total of 34 conditions setting out the requirements that the Company must satisfy. The Company holds one land use consent for the purpose of piping a stream, two consents to discharge wood waste onto and into land, and one consent to discharge leachate and stormwater to land and water.

Overall an improvement is required in the Company's environmental performance with their resource consents.

The Council's monitoring programme for the period under review included four inspections, 14 water samples, and two soil samples collected for physicochemical analysis.

At the Monk Road site it was found that little, if any, wood waste had been disposed of in the time leading up to each of the monitoring inspections. There were no unauthorised materials found to have been discharged at the site. It was found that leachate at the Monk Road site still has potential to cause effects, and elevations in the concentration of contaminants were noted. The biological oxygen demand and dissolved arsenic concentrations below the mixing zone exceeded consent limits. These parameters each exceeded consent limits at the site below the mixing zone at one of the three sampling surveys. It was found that the culvert conveying the tributary under the fill had become blocked causing the water level in the upstream pond to rise and come in contact with the uncapped fill, and that stock access had been allowed on the cap causing pugging. These issues have the potential to increase leachate generation from the site, which was evident to some degree in the receiving water sampling as discussed above, and the biochemical oxygen demand exceedance, although minor in nature, was in contravention of an abatement notice issued in June 2017.

The Management Plan provided in the 2016-2017 year for the Monk Road site indicated that the cap would not comply with the conditions of the consent. The Company was advised that the cap design and the plan would need to be amended to ensure that the conditions of the consent were met. A revised plan is still to be received.

At the Village Settlement Road discharge site, remediation undertaken during the 2013-2014 year has, on the whole, remained effective and stable during the 2017-2018 year. The site surface was found to be stable with good vegetative cover. Soil sample results beyond the boundary complied with relevant consent conditions. A marginal exceedance (within the uncertainty of measurement of the test method) of the copper concentration was detected in the buffer zone within the site boundary. Follow-up monitoring is recommended in spring 2018.

With consideration to the issues outlined above, an improvement is required in the Company's level of environmental and administrative performance with the resource consents as defined in Section 1.1.4 of the report.

For reference, in the 2017-2018 year, consent holders were found to achieve a high level of environmental performance and compliance for 76% of the consents monitored through the Taranaki tailored monitoring programmes, while for another 20% of the consents, a good level of environmental performance and compliance was achieved.

In terms of overall environmental and compliance performance by the consent holder, historically the Company had generally been compliant, however, the Company's performance has deteriorated in the last three years.

This report includes recommendations for the 2018-2019 year.

1 Introduction

1.1 Compliance monitoring programme reports and the Resource Management Act 1991

1.1.1 Introduction

This report is for the period July 2017 to June 2018 by the Taranaki Regional Council (the Council) on the monitoring programme associated with resource consents held by Waverley Sawmills Ltd (the Company). The Company operates two landfill (monofill – wood waste) sites. One site is situated on Monk Road at Waverley, in the Whenuakura catchment (consents 6413-2, 6412-1 and 7342-2). The other site, now closed, is on Village Settlement Road in the Moumahaki catchment (consent 6528-2).

One of the intents of the *Resource Management Act 1991* (RMA) is that environmental management should be integrated across all media, so that the Company's use of water, air, and land should be considered from a single comprehensive environmental perspective. Accordingly, the Council generally implements integrated environmental monitoring programmes and reports the results of the programmes jointly. This report discusses the environmental effects of the Company's use of water, land and air, and is the eleventh combined annual report by the Council for the Company.

1.1.2 Structure of this report

Section 1 of this report is a background section. It sets out general information about:

- consent compliance monitoring under the RMA and the Council's obligations;
- the Council's approach to monitoring sites though annual programmes;
- the resource consents held by the Company in the Whenuakura and Moumahaki catchments;
- the nature of the monitoring programme in place for the period under review, and
- a description of the activities and operations conducted at each of the two wood waste disposal sites.

Section 2 presents the results of monitoring during the period under review, including scientific and technical data.

Section 3 discusses the results, their interpretations, and their significance for the environment.

Section 4 presents recommendations to be implemented in the 2018-2019 monitoring year.

A glossary of common abbreviations and scientific terms, and a bibliography, are presented at the end of the report.

1.1.3 The Resource Management Act 1991 and monitoring

The RMA primarily addresses environmental 'effects' which are defined as positive or adverse, temporary or permanent, past, present or future, or cumulative. Effects may arise in relation to:

- a. the neighbourhood or the wider community around a discharger, and may include cultural and social-economic effects;
- b. physical effects on the locality, including landscape, amenity and visual effects;
- c. ecosystems, including effects on plants, animals, or habitats, whether aquatic or terrestrial;
- d. natural and physical resources having special significance (for example, recreational, cultural, or aesthetic); and

e. risks to the neighbourhood or environment.

In drafting and reviewing conditions on discharge permits, and in implementing monitoring programmes, the Council is recognising the comprehensive meaning of 'effects' inasmuch as is appropriate for each discharge source. Monitoring programmes are not only based on existing permit conditions, but also on the obligations of the RMA to assess the effects of the exercise of consents. In accordance with Section 35 of the RMA, the Council undertakes compliance monitoring for consents and rules in regional plans, and maintains an overview of the performance of resource users and consent holders. Compliance monitoring, including both activity and impact monitoring, enables the Council to continually re-evaluate its approach and that of consent holders to resource utilisation, to move closer to achieving sustainable development of the region's resources.

1.1.4 Evaluation of environmental and consent performance

Besides discussing the various details of the performance and extent of compliance by the Company, this report also assigns them a rating for their environmental and administrative performance during the period under review.

Environmental performance is concerned with <u>actual or likely effects</u> on the receiving environment from the activities during the monitoring year. Administrative performance is concerned with the Company's approach to demonstrating consent compliance in site operations and management including the timely provision of information to Council (such as contingency plans and water take data) in accordance with consent conditions.

Events that were beyond the control of the consent holder <u>and</u> unforeseeable (that is a defence under the provisions of the RMA can be established) may be excluded with regard to the performance rating applied. For example loss of data due to a flood destroying deployed field equipment.

The categories used by the Council for this monitoring period, and their interpretation, are as follows:

Environmental Performance

- **High:** No or inconsequential (short-term duration, less than minor in severity) breaches of consent or regional plan parameters resulting from the activity; no adverse effects of significance noted or likely in the receiving environment. The Council did not record any verified unauthorised incidents involving significant environmental impacts and was not obliged to issue any abatement notices or infringement notices in relation to such impacts.
- **Good:** Likely or actual adverse effects of activities on the receiving environment were negligible or minor at most. There were some such issues noted during monitoring, from self reports, or in response to unauthorised incident reports, but these items were not critical, and follow-up inspections showed they have been dealt with. These minor issues were resolved positively, co-operatively, and quickly. The Council was not obliged to issue any abatement notices or infringement notices in relation to the minor non-compliant effects; however abatement notices may have been issued to mitigate an identified potential for an environmental effect to occur.

For example:

- High suspended solid values recorded in discharge samples, however the discharge was to land or to receiving waters that were in high flow at the time;
- Strong odour beyond boundary but no residential properties or other recipient nearby.
- **Improvement required**: Likely or actual adverse effects of activities on the receiving environment were more than minor, but not substantial. There were some issues noted during monitoring, from self

reports, or in response to unauthorised incident reports. Cumulative adverse effects of a persistent minor non-compliant activity could elevate a minor issue to this level. Abatement notices and infringement notices may have been issued in respect of effects.

Poor: Likely or actual adverse effects of activities on the receiving environment were significant. There were some items noted during monitoring, from self reports, or in response to unauthorised incident reports. Cumulative adverse effects of a persistent moderate non-compliant activity could elevate an 'improvement required' issue to this level. Typically there were grounds for either a prosecution or an infringement notice in respect of effects.

Administrative performance

- **High:** The administrative requirements of the resource consents were met, or any failure to do this had trivial consequences and were addressed promptly and co-operatively.
- **Good:** Perhaps some administrative requirements of the resource consents were not met at a particular time, however this was addressed without repeated interventions from the Council staff. Alternatively adequate reason was provided for matters such as the no or late provision of information, interpretation of 'best practical option' for avoiding potential effects, etc.
- **Improvement required:** Repeated interventions to meet the administrative requirements of the resource consents were made by Council staff. These matters took some time to resolve, or remained unresolved at the end of the period under review. The Council may have issued an abatement notice to attain compliance.
- **Poor:** Material failings to meet the administrative requirements of the resource consents. Significant intervention by the Council was required. Typically there were grounds for an infringement notice.

For reference, in the 2017-2018 year, consent holders were found to achieve a high level of environmental performance and compliance for 76% of the consents monitored through the Taranaki tailored monitoring programmes, while for another 20% of the consents, a good level of environmental performance and compliance was achieved.

1.2 Process description

In 2002, the Company was in the process of carrying out due diligence with regard to potential purchase of the sawmill. During this process the new owners noted that the sites to which their mill wood waste was being discharged did not have resource consents to cover these activities. While the Company viewed the issue of consenting the disposal site strictly a matter for the disposal contractor, they considered it good environmental governance to make it their business, and become involved.

As a result, the Company applied for and were granted consent to install a culvert at the Monk Road site and a consent to discharge untreated wood waste to the site. They were later granted a consent to discharge treated wood waste to a site on Village Settlement Road.

As a result of ongoing leachate generation from historical filling at the Monk Road site, the Company applied for, and were granted, a consent to discharge stormwater and leachate to land and water in August 2008. This consent was renewed in 2010.

Wood waste is generated at the sawmill at various stages of the timber processing operation, from debarking through to gauging. In the course of applying for resource consent to discharge treated wood waste, the Company identified ways to reduce the quantity of treated wood waste produced. One of these measures included machining timber products before they were treated with preservative whenever possible. Such alterations to the production process have significantly reduced the quantity of treated wood waste for disposal at Bonny Glen landfill. More recently (May 2015), a new wood waste boiler was commissioned. This boiler is fuelled with sawdust and takes the 15,000 m³ per annum of sawdust that would previously have been trucked to Monk Road. Any additional sawdust required is sourced from another sawmill within the Taranaki region. During the year under review, the Company found alternative uses for untreated wood waste generated at the site, with the diversion of up to 3,000 m³/yr of shavings for animal bedding, up to 9,500 m³/yr of bark and wood fibre to a compost company. These initiatives have reduced the estimated volume of wood waste going to the Monk Road site to the order of about 2,500 m³/yr.

The site at Monk Road is a gully in the upper reaches of a catchment that is predominately comprised of dairy farm land. Immediately above the discharge area is a small farm dam. The Company installed a culvert at the site that piped the tributary from this dam around and downstream of the discharge area, effectively bypassing the discharge area. The aim of this work was to reduce the quantity of water entering the discharge area and coming into contact with the wood waste discharged therein.

After this development was completed, and prior to the purchase of the sawmill by the current owners, a spring was discovered under the filled area. It was found that the spring was dissolving and mobilising contaminants from the fill, that is, generating leachate. The leachate was found to be discharging into the unnamed tributary of the Kohi Stream. The presence of copper, chromium and arsenic in the leachate indicated that treated wood waste had been disposed of at the site in the past. A consent to permit this leachate discharge was obtained by the Company in August 2008 and the consent was renewed in October 2010.

The discharge site on Village Settlement Road was chosen because it is elevated and therefore dry. The site is small in size compared to the Monk Road site and while it is situated close to an unnamed tributary at the north west end of the site, the surface gradient and contours ensure that surface water from the site flows in a south easterly direction, away from the water body. The Company is now at the point that it produces no treated wood waste as all machining is done prior to treatment. As a result, the Company's Village

Settlement Road site was closed in June 2014. Site remediation work was undertaken in the 2013-2014 year to ensure that the consent soil component concentrations for the cap and surface soils down gradient of the fill area were met. This was discussed in the 2013-2014 Annual Report.

1.3 Resource consents

The Company holds four resource consents the details of which are summarised in the table below and outlined in sections 1.3.1 to 1.3.3.

1.3.1 Discharge to water

Section 15(1)(a) of the RMA stipulates that no person may discharge any contaminant into water, unless the activity is expressly allowed for by a resource consent or a rule in a regional plan, or by national regulations.

The Company holds discharge permit **7342-2** to cover the discharge of leachate and stormwater from a sawmill waste disposal site to water and into land where it may enter in an unnamed tributary of the Kohi Stream. This permit was originally issued by the Council on 7 October 2010 under Section 87(e) of the RMA, with changes made on 4 March 2014, reducing the amount of sampling required at the site. The consent is due to expire on 1 June 2028.

The permit has four special conditions.

Condition 1 requires that the consent holder adopt the best practicable option to prevent or minimise effects.

Conditions 2 and 3 limit certain parameters in the unnamed tributary of the Kohi Stream and prohibit certain effects beyond defined mixing zones.

Condition 4 is a review condition.

The permit is attached to this report in Appendix I.

This summary of consent conditions may not reflect the full requirements of each condition. The consent conditions in full can be found in the resource consent which is appended to this report.

1.3.2 Discharges of wastes to land

Sections 15(1)(b) and (d) of the RMA stipulates that no person may discharge any contaminant onto or into land if it may then enter water, or from any industrial or trade premises onto land under any circumstances, unless the activity is expressly allowed for by a resource consent, a rule in a regional plan, or by national regulations.

The Company held discharge permit **6413-2.0** to cover the discharge of wood waste from sawmilling operations onto and into land. This permit was issued by the Council on 31 May 2012 under Section 87(e) of the RMA. It was due to expire on 1 June 2028.

The original consent permitted only the disposal of untreated sawdust, shavings and bark. A varied consent was granted on 2 February 2016 amending special condition 2 to provide for the disposal of additional untreated wood wastes and furnace ash (**6413-2.1**). The expiry date of the varied consent remains 1 June 2028.

Condition 1 relates to the provision of a management plan for the site.

Condition 2 specifies that only the following untreated materials be discharged to the site:

Untreated wood shavings, sawdust, bark, slovens and sawmill waste, morbark chipper slovens, chunks and fines, batten plant and processing shed off-cuts, broken fillet sticks, furnace ash, and yard sweepings.

Condition 3 requires that the discharges only be made to a certain area.

Condition 4 requires that the consent holder be the sole source of materials discharged.

Condition 5 requires that discharged materials do not enter water.

Condition 6 requires the consent holder to adopt the best practicable option to prevent or minimise effects when exercising the consent.

Condition 7 specifies the requirements for capping and reinstatement.

Condition 8 relates to review of the consent.

The Company holds discharge permit **6528-2** to cover the discharge of wood waste from sawmilling operations onto and into land. This permit was issued by the Council on 31 July 2012 under Section 87(e) of the RMA. This consent expires on 1 June 2022.

Condition 1 requires the consent holder to adopt the best practicable option to prevent or minimise effects when exercising the consent.

Condition 2 relates to the provision of a management plan for the site.

Condition 3 specifies that only treated and untreated shavings sawdust and bark can be discharged to the site.

Condition 4 specifies the area in which the discharges may occur.

Condition 5 states that the consent holder shall be the sole supplier of waste to the site and special condition 6 deals with the control of stormwater on the site.

Conditions 7, 10 and 11 relate to capping requirements.

Conditions 8 and 9 set out maximum component concentration limits allowed in the soil at certain areas of the site.

Conditions 12 and 13 require the consent holder to notify Council of certain events.

Conditions 14 and 15 set out post closure monitoring requirements, and condition 16 is a review condition.

The permits are attached to this report in Appendix I.

This summary of consent conditions may not reflect the full requirements of each condition. The consent conditions in full can be found in the resource consents which are appended to this report.

1.3.3 Land use permit

Section 13(1)(a) of the RMA stipulates that no person may in relation to the bed of any lake or river use, erect, reconstruct, place, alter, extend, remove, or demolish any structure or part of any structure in, on, under, or over the bed, unless the activity is expressly allowed for by a resource consent, a rule in a regional plan, or by national regulations.

The Company holds land use permit **6412-1** to culvert an unnamed tributary of the Kohi Stream for land improvement purposes associated with cleanfill activity. The Council issued this consent on 4 March 2005 as a resource consent under Section 87(e) of the RMA. It is due to expire on 1 June 2022.

Condition 1 requires the consent holder to adopt the best practicable option to prevent or minimise the discharge of silt or other contaminants into or onto the streambed and to avoid or minimise the disturbance of the streambed and any adverse effects on water quality.

Condition 2 states that the exercise of the consent should be undertaken in accordance with documents submitted with the application.

Condition 3 requires the consent holder to notify the Council 48 hours before and after works occur on site.

Condition 4 requires that the exercise of the consent shall not cause ponding on upstream properties.

Condition 5 relates to the lapse of the consent after five years if not exercised.

Condition 6 deals with review of the consent.

A copy of the consent is included in Appendix I of this report.

This summary of consent conditions may not reflect the full requirements of each condition. The consent conditions in full can be found in the resource consent which is appended to this report.

1.4 Monitoring programme

1.4.1 Introduction

Section 35 of the RMA sets obligations upon the Council to gather information, monitor and conduct research on the exercise of resource consents within the Taranaki region. The Council is also required to assess the effects arising from the exercising of these consents and report upon them.

The Council may therefore make and record measurements of physical and chemical parameters, take samples for analysis, carry out surveys and inspections, conduct investigations, and seek information from consent holders.

The monitoring programme for the Company's wood waste disposal sites consisted of three primary components.

1.4.2 Programme liaison and management

There is generally a significant investment of time and resources by the Council in:

- ongoing liaison with resource consent holders over consent conditions and their interpretation and application;
- in discussion over monitoring requirements;
- preparation for any consent reviews, renewals or new consent applications;
- advice on the Council's environmental management strategies and content of regional plans; and
- consultation on associated matters.

1.4.3 Site inspections

Three routine compliance monitoring inspection were carried out at the Monk Road site and the Village Settlement Road site during the monitoring period. With regard to consent for the disposal of wood waste onto and into land at both sites, the main points of interest were site processes with potential or actual discharges to receiving watercourses, including contaminated stormwater. Air inspections focused on plant processes with associated actual and potential emission sources and characteristics, including potential odour, dust, noxious or offensive emissions. Sources of data being collected by the Company were identified and accessed, so that performance in respect of operation, internal monitoring, and supervision could be reviewed by the Council. An additional site visit was made to the Monk Road site on 20 February 2018 to discuss non-compliances and the Company's feedback on the 2016-2017 Annual Report.

1.4.4 Chemical sampling

The Council undertook sampling at both discharge sites. These included leachate samples, surface water samples, wood waste samples and soil samples.

2 Results

2.1 Inspections

2.1.1 Monk Road site

28 November 2017

At the time of inspection the upstream tributary was discharging via the weir. The downstream leachate flow was found to be slightly turbid, slightly brackish brown in colour with a slight organic type odour. The tributary bypass discharge was light brown in colour with no distinguishable odour. In light of the high biochemical oxygen demand found in the sample collected at KOI000130 at the previous inspection (18 May 2017), the Kohi Stream was checked approximately 200 m downstream that sampling site. No heterotopic growths (sewerage fungus) were noted on the stream bed. No water quality samples were collected at this location on this occasion as the stream appeared to be flowing relatively clear. The Company was informed that a further investigation may be warranted in the future. At the fill site it was found that there had been no recent deliveries of sawdust to the site. The sawdust area appeared to be free of treated sawdust and other unauthorised materials. The most northern area of the site had been partially capped, with some vegetation establishing. This was noted to be mainly weed growth. The inspecting officer contacted one of the Company Directors regarding leachate seepage from the sawdust pile along the northern face (Photo 3 and Photo 4).

The inspecting officer was informed that this was a direct result of a blockage in the pipe causing the water in the tributary on the upstream side of the fill to back up (approximately 0.5 m above the level of the weir). It was stated that the high water level covered the toe of the sawdust pile and when the water receded, leachate seeped from the sawdust but did not enter the stream. The blockage was found approximately 80 m upstream of the manhole and it took 10 days to complete repairs. The Company was asked to provide the programme manager with the explanation and findings in relation to this occurrence, and the matter was recorded as a non-compliance on the incident register, which is discussed further in section 2.3.

4 April 2018

At the time of inspection it was found that there was no evidence that any sawdust material had recently been delivered to the site. The leachate/spring water discharge flow was estimated at 0.25 L/s where it was discharging via the culvert on the southern side of Monk Road. White foaming was observed at the point of discharge on the downstream side of the road culvert, but it was not evident beyond the discharge point. The discharge had a distinctive light organic type odour. It was noted that the vegetation growing in the tributary downstream of the discharge appeared to be healthy. At the fill site it was found that the upstream tributary was not discharging over the weir and it was noted that the outlet pipe from the bypass drain was dry. There was no discharge from the eastern leachate/spring water pipe in the manhole down gradient of the fill area. The flow in the tributary downstream of the site was found to be relatively clear, slightly green in colour, with no distinguishable odour. It was found that the vegetation along the north face of the sawdust pit has now regrown where the blocked culvert had caused upstream flooding and die-off. The upper sawdust area was covered by grass and weed growth, but was only partially capped at that stage. It was noted that the farmer had used this area as a holding pad during the 2017 winter months. The Company was advised that intensive stocking on monofill/landfill caps causes pugging and ponding that is likely to increase leachate generation, and is therefore not appropriate. The Company was also advised that at the time of inspection, the cap did not meet the requirements of special condition 7 of consent 6413-2. Although this was not technically a non-compliance until the filling activity had been completed, it did mean the cap would not be able to withstand high stocking rates, mature stock, or use as a holding pad during wet periods.

The inspecting officer was informed that the diversion of wood waste was still going well with the following diversions in place:

- 30 m³/day bark to NZ Composting
- 10 m³/day super shavings to Wanganui
- 60 m³/day sawdust burnt onsite via the boiler
- 100 m³/day of ash, treated offcuts, mill waste etcetera to Waste Management in Wanganui.

The following action was to be undertaken:

• As per special condition 6 of consent 6413-2, which requires the best practicable option be adopted to minimise effects, ensure that grazing is limited to light weight stock at a low stocking density for short durations to avoid cap damage.

21 June 2018

The inspecting officer was accompanied by one of the Company Directors on this occasion. It was noted that the upstream tributary was discharging over the weir. It was found that no sawdust had been disposed at the Monk Road site recently. It was observed that no further work had been carried out on the cap and the inspecting officer was informed that the Director may talk with the land owner regarding contouring the lower site. The leachate/spring water discharge via the culvert on the downstream side of Monk Road was estimated to be flowing at about 4 L/sec. There was visible foaming present, but this was only in the immediate vicinity of the discharge point. It was noted that the flow had a distinctive leachate type odour.

2.1.2 Village Settlement Road site

28 November 2017

This area remains stable showing good pasture growth. No soils samples were collected on this occasion.

4 April 2018

There were no concerns found in relation to the old sawdust site at the time of inspection.

21 June 2018

There were no visual evidence of any issues in relation to this old sawdust site. The pasture growing on the capped sawdust disposal area appeared to be healthy with no slumping or leachate seepage evident. Soil samples were collected and composited on site, either inside (SOL000179) and outside (SOL000180) the southern boundary.

2.2 Soil, wood waste, and water monitoring

2.2.1 Monk Road site

The discharge and receiving waters upstream and downstream of the site are scheduled to be sampled at each of the three routine monitoring inspections. The sampling sites are shown in Figure 2.

2.2.1.1 Results of discharge monitoring

IND001055 was previously located in an open drain below the fill site, which is fed by a spring that originates (and is culverted) under the fill. At the inspection on 20 September 2017, it was found that the remainder of the drain had been piped, with a manhole installed downstream of the remaining area to be filled. Three samples of the discharge were collected during the monitoring period, two of which were obtained from the pipe outlet within the manhole, and one of which was obtained from the Monk Road culvert outlet. The results of this sampling are presented in Table 2.

2.2.1.2 Results of receiving environment monitoring

Scheduled water samples were collected on three occasions from an unnamed tributary of the Kohi Stream upstream (KHI000100) and downstream (KHI000130) of the consented mixing zone (Table 4). The sites used for sampling are shown in Figure 2. A sample was also collected from the piped tributary outlet in the recently installed manhole riser immediately downstream of the fill area on 28 November 2017 (Table 3).

There was an increase in the dissolved arsenic concentration of the tributary at the outlet of the bypass culvert pipe indicating that minor amounts of leachate are able to enter this culvert.

During the period under review it was found that the spring water at the source (site IND001055) continued to show higher than usual levels of dissolved arsenic and BODCF when compared to 2008 to 2013, whereas the chromium and copper levels appear to have returned to the earlier levels, as shown in Figure 3, Figure 4, Figure 5, and Figure 6.

Since the massive spike in contaminant loads in 2007 was noted in the leachate/spring water discharge, the levels of contaminants in this spring water had reduced and remain relatively consistent. This trend came to an end in the 2013-2014 year, when levels of BOD, copper, chrome and arsenic all increased. Since then, and during the period under review the BOD and arsenic have remained elevated to varying degrees, although the copper and chromium concentrations appeared to return to the former levels during the year under review. These changes indicate that the nature of the discharge has changed and should continue to be monitored.

It is also noted that the pH of the discharge from the wood waste disposal area has decreased, resulting in the discharge/spring water sampled at IND001055 becoming more acidic. The combination of the elevated temperature at this site (Figure 7) and its more acidic pH is likely to be the cause of the mobilisation of metals from treated timber wood waste that was thought to have been disposed of at the site under previous management. This was prior to consent being sought by the current consent holder. The apparent pH dependence is shown in Figure 8 and Figure 9, but is noted that the effect observed at the downstream site will also depend on the relative flow rates of the tributary and the leachate/spring water at the time that the grab samples were collected.

Notwithstanding the increases in contaminant loads within the discharge, after mixing with the unnamed tributary downstream of the sampling site and passage through the wetland, the discharge at the compliance point (site KOI000130), was generally within the specified limits given in the consent conditions. The exceptions to this were a minor exceedance of BODCF on 28 November 2017 and of the dissolved arsenic in the sample collected on 21 June 2018.

Although only a minor exceedance in the BODCF (4 g/m³ versus a consent limit of 3 g/m³), this was recorded as an unauthorised discharge due to the previous, albeit larger, exceedances of this parameter during the 2016-2017 year that resulted in an abatement notice having been issued requiring action be taken to reduce the BODCF to below 3.0 g/m³ and dissolved arsenic to below 0.1 g/m³ at site KOI000130. The consent non-compliance is discussed in more detail in Section 2.3

The arsenic concentration was found to have been compliant with consent conditions at the first sampling survey undertaken during the 2018-2019 year.

2.2.1.3 Sampling of discharged material

Wood waste sampling was scheduled to be undertaken at the Monk Road site, however there had been no recent loads of wood waste disposed of at the site at the times the inspections were undertaken.

2.2.2 Village Settlement Road site

Soil samples were taken from the capped areas, on virgin ground down-gradient of the landfill footprint and from the neighbouring property. The sampling sites are shown in Figure 10 and the results of the soil analysis are given in the following tables.

2.2.2.1 Outside landfill footprint - site SOL000179

On 21 June 2018, 10 cores were taken across a transect running parallel to and about 5 m inside the eastern boundary fence, avoiding areas in close proximity to the tanalised fence posts. These cores were made into a composite sample and analysed for CCAB, as consent 6528-2 contains limits for these components and require the area to be remediated should CCAB levels exceed those limits once filling operations have been completed.

Sample results (given in Table 5 below) show the component concentrations in the soil inside the down gradient boundary complied with the post closure limits contained in consent 6528-2, with the exception of the arsenic concentration. The uncertainty of measurement on this determination is +/- 6.5 mg/kg, so this was not treated as a non-compliance. The composite taken from beyond the site boundary still had low

(acceptable) levels of arsenic present, but was on the consent limit for copper (Table 6). In response to these results, the Company was advised that the Council would resample in spring 2018, in addition to the programmed annual sampling.

2.2.2.2 Neighbouring property - site SOL000180

Ten cores were taken across a transect running parallel to and about 5 m outside the eastern boundary fence, again avoiding areas in close proximity to the tanalised fence posts. These cores were made into a composite sample and analysed for CCAB contaminants. The results, given in Table 6 below, showed that this area was compliant with consent conditions in regards to CCAB post closure limits set out by the consent.

2.3 Investigations, interventions, and incidents

The monitoring programme for the year was based on what was considered to be an appropriate level of monitoring, review of data, and liaison with the Company. During the year matters may arise which require additional activity by the Council, for example provision of advice and information, or investigation of potential or actual causes of non-compliance or failure to maintain good practices. A pro-active approach that in the first instance avoids issues occurring is favoured.

The Council operates and maintains a register of all complaints or reported and discovered excursions from acceptable limits and practices, including non-compliance with consents, which may damage the environment. The incident register includes events where the Company concerned has itself notified the Council. The register contains details of any investigation and corrective action taken.

Complaints may be alleged to be associated with a particular site. If there is potentially an issue of legal liability, the Council must be able to prove by investigation that the identified company is indeed the source of the incident (or that the allegation cannot be proven).

In the 2017-2018 period, the Council was required to undertake additional investigations and interventions, recording one incident in association with the Company's conditions in resource consents and provisions in Regional Plans.

28 November 2017

A routine monitoring sample collected at the compliance point in the Kohi Stream (KOI000130) showed that at the time of the survey the BODCF exceeded the concentration permitted by special condition 3 of consent 7342-2.1.

It was therefore determined that there was a discharge of contaminants, namely sawmill wood waste leachate, onto or into land in circumstances which may have resulted in that contaminant (or any other contaminant emanating as a result of natural processes from that contaminant) entering water, namely the Kohi Stream, when the discharge was not expressly allowed by a national environmental standard or other regulations, a rule in a regional plan, or a resource consent. This exceedance was also a breach of the abatement notice issued to the Company in June 2017, which required the Company to undertake works to the Monk Road sawdust-waste disposal site to ensure that all special conditions of resource consent 7342-2.1 are complied with at all times

An onsite meeting was held with the consent holder to outline the Council's concerns. Further sampling of the receiving water by both the Company on 12 January 2019 and the Council on 4 April 2018 found that the samples were compliant with resource consent conditions, and no heterotrophic growths were found in the receiving waters beyond the mixing zone. The Council is continuing to work with Waverley Sawmills Ltd to assess the site to see what improvements can be made to mitigate offsite effects. No further enforcement action was taken at this stage and the Council was working with the consent holder to achieve compliance.

2.4 Discussion of site performance

2.4.1 Monk Road site

Following the installation and commissioning of the wood waste boiler at the timber treatment plant, which has been used to dispose of the untreated and tanalith E treated sawdust since May 2015, the Company continued to investigate other waste diversion options during the year under review.

Further initiatives introduced during the year under review were:

- Diversion of debarking waste to a composting company, reducing the volume discharged at Monk Road by up to 9,500 m³/year; and
- Diversion of shaving from the planar to a company that sells animal bedding, further reducing the volume discharged by up to 3,000 m³/year.

There was no evidence of illegal dumping found, and little, if any, wood waste was found to have been discharged at the property in the weeks prior to the inspections. No unauthorised wood waste was found at the site at the time of the inspections.

There were no odour or dust issues noted during any of the inspections and no complaints were received about the site. The pipe installed under the fill was functional and was of sufficient length in the spring channel to ensure separation of the spring water from the wood waste as required by consent conditions. However, the pipe conveying the tributary under the fill was found to have been obstructed during the year under review. This resulted in the pond level rising to 4-5 feet above the inlet level for the rigid pipe carrying the ponds water under the landfill. This increase in the level of the pond would have resulted in the pond water being above the base level of the fill, giving rise to the potential for infiltration and increased leachate generation. The Company advised that the damaged culvert pipe was removed, with an open trench being dug back to the concrete sump near Monk Road, allowing the water level in the upstream pond to stabilise. Once the water levels had stabilised, a new rigid pipe was laid in the trench connecting the original pipe to the concrete sump.

2.4.2 Village Settlement Road site

The cap was found to be in a satisfactory condition, with healthy vegetative cover across the site and no evidence of slumping was observed.

2.5 Environmental effects of exercise of consents

2.5.1 Monk Road site

The discharge of leachate from the site was still having an effect on the environment immediately downstream of the discharge, and it was noted that while contaminant levels in the discharge initially decreased there was an increase in arsenic concentration towards the end of the year. The receiving water quality conditions were met at the compliance point during the April survey, but there was a marginal breach of the BODCF limit at the November survey and the dissolved arsenic limits was exceeded in the June survey. There were no significant adverse effects (for example heterotrophic growths or fish kills) observed at the time of the sampling surveys. However, the BODCF exceedance was in contravention of an abatement notice issued to the Company in June 2017. This was logged as an unauthorised incident and Waverley Sawmills Ltd was continuing to investigate improvements that can be made to mitigate offsite effects.

2.5.2 Village Settlement Road site

Sampling by the Council showed that the remediation works undertaken in the 2013-2014 year have continued to have been successful, for the most part. The site remained compliant with consent conditions beyond the site boundary, however, there was a marginal exceedance of the copper limit for the buffer strip, which was within the uncertainty of measurement of the test method.

It is noted that the site must remain compliant with the post closure component concentrations for at least five years, after which time consideration may be given to allowing the consent being surrendered on application from the Company. It should also be noted that the consent conditions were designed to reduce risk to the neighbour's property rather than being designed to have the site remediated to any particular land use guideline. It is recommended that an additional soil sampling survey be undertaken in spring 2018.

2.6 Evaluation of performance

A tabular summary of the Company's compliance record for the period under review is set out in Table 7 to Table 10.

During the year, an improvement was required in the Company's level of environmental and administrative performance with the resource consents as defined in Section 1.1.4. The biological oxygen demand and dissolved arsenic concentrations below the mixing zone each exceeded their respective consent limits on one of the three monitoring occasions. The biological oxygen demand exceedance, although minor, was in contravention of an abatement notice. A blockage occurred in the tributary bypass culvert resulting in the water in the pond backing up and coming in contact with uncapped fill and stock have been allowed access to the uncapped fill. The management plan provided during the 2016-2017 year indicated that the cap would not comply with consent conditions. The Company was advised of this and the Council is still awaiting a revised plan.

2.7 Recommendations from the 2016-2017 Annual Report

In the 2016-2017 Annual Report, it was recommended:

- 1. THAT, in the first instance, monitoring of discharges from Waverley Sawmills Ltd sites on Monk Road and Village Settlement Road in the 2017-2018 year continues at the same level as in 2016-2017.
- 2. THAT the option for a review of resource consent 6528-2 in June 2018, as set out in condition 16 of the consent, not be exercised, on the grounds that the current conditions are adequate to deal with adverse environmental effects.
- 3. THAT should there be issues with environmental or administrative performance in 2017-2018, monitoring may be adjusted to reflect any additional investigation or intervention as found necessary.

The Council recommendations were implemented, with the exception of the wood waste sample analysis as there were no recent loads at the site at the time the inspections were undertaken.

2.8 Alterations to monitoring programmes for 2018-2019

In designing and implementing the monitoring programmes for air/water discharges in the region, the Council has taken into account:

- its relevance under the RMA;
- the Council's obligations to monitor consented activities and their effects under the RMA;
- the record of administrative and environmental performances of the consent holder; and
- reporting to the regional community.

The Council also takes into account the scope of assessments required at the time of renewal of permits, and the need to maintain a sound understanding of industrial processes within Taranaki exercising resource consents.

It is proposed that for 2018-2019 that, on the whole, the programme remains unchanged from that of 2017-2018, but with the addition of one additional set of boundary soil samples at the Village Settlement Road site in follow-up to the elevated results obtained in June 2018.

It should be noted that the proposed programme represents a reasonable and risk-based level of monitoring for the site in question. The Council reserves the right to adjust this baseline programme should the need arise if potential or actual non-compliance is determined at any time during 2018-2019.

3 Recommendations

- 1. THAT, in the first instance, monitoring of discharges from Waverley Sawmills Ltd sites on Monk Road and Village Settlement Road in the 2018-2019 year continues at the same level as in 2017-2018, but with one set of follow-up boundary soil samples at the Village Settlement Road site.
- 2. THAT should there be issues with environmental or administrative performance in 2018-2019, monitoring may be adjusted to reflect any additional investigation or intervention as found necessary.

 - d) concentration of dissolved arsenic demand no greater than 0.1 g/m^3 .
- 4. In accordance with section 128 and section 129 of the Resource Management Act 1991, the Taranaki Regional Council may serve notice of its intention to review, amend, delete or add to the conditions of this resource consent by giving notice of review during the month of June 2012, 2014, 2016 and/or June 2022 for the purpose of ensuring that the conditions are adequate to deal with any adverse effects on the environment arising from the exercise of this resource consent, which were either not foreseen at the time the application was considered or which it was not appropriate to deal with at the time.
