Taranaki PHU is one of 12 public health units providing public health services across Aotearoa/New Zealand. We provide a range of services with a focus on promoting health equity and protecting communities against public health hazards, including through a Wellbeing in All Policies approach (WiAP).

Taranaki PHU is committed to creating a fairer society where everyone has the opportunity for good health, and where our societal systems consider the needs and aspirations of Māori as tangata whenua and work in partnership with Māori through the application of Te Tiriti o Waitangi articles and principles.




Figure 1 The Determinants of Health and Wellbeing in Communities (Whitehead & Dahlgren, 2006)

WiAP is a cross-sectoral approach to policy that considers the health and wellbeing implications of policy decisions, in order to improve population health and equity. Many of the determinants of health lie beyond the control or influence of the health sector and the individual and form a complex system of factors that determine health outcomes (Figure 1). The decisions of local government play a direct role in the determinants of health in communities.

Taranaki PHU supports the Taranaki Regional Council reviewing its representation arrangements and creating a Māori Constituency and commend this as a proactive approach to further the health and wellbeing aspirations of communities in Taranaki.


Councils make decisions that improve the wellbeing of all their communities:

The Local Government (Community Well-being) Amendment Act 2019 requires local authorities to promote 'the social, economic, environmental and cultural well-being of communities in the present and for the future' (Section 10(1b))¹. There is no one definition of wellbeing. Wellbeing can be measured differently according to people's values, their beliefs and social norms.

The Māori view of wellbeing is informed by te ao Māori (a Māori world view) where, for example, the value of land lies in cultural concepts such as whakapapa (genealogy), wairua (spiritual connections) and kaitiakitanga (stewardship), as well as economic potential.² Local government acknowledgement of te ao Māori and meaningful inclusion of Māori in decision making and policy development, both as Te Tiriti o Waitangi partners and as citizens with a significant stake in local government decisions, will further the health and wellbeing aspirations of Māori in Taranaki.³

Comments:

To favour one racial group over another is a fundamental rejection of democracy. It is clearly intended to skew the collective decision making of elected local bodies in favour of one particular point of view, rather than outcomes that favour the interests of the whole community. It's as destructive of democracy to give Maori a guaranteed seat at the Council table, as giving one to, for example, the Chamber of Commerce or the rugby club or any other narrowly focused lobby group.

Maori interests are quite capable of being expressed through the normal consultation process (as illustrated by this submission) and Maori are as capable of organising themselves to contest, and win, seats at the Council table as any other ethnic group. To suggest otherwise is an insult to Maori.

Nor is it valid to argue that Maori constituencies are required by the Treaty of Waitangi because democracy in the modern sense simply did not exist in 1840. Local bodies did not exist, and could not have been a part of Busby's plan. Indeed, Maori retained full possession of their properties under Article 2 and the signing chiefs would have been bemused by the concept having their authority subject to challenge by some wider body.

Article 1 of the Treaty vested sovereignty in the Queen of England, but as democracy developed this evolved into the sovereignty of the People as expressed through the New Zealand Parliament. Maori electorates were provided to give Maori a voice in Parliament because the franchise was based on individual ownership of land and Maori land tended to be collectively owned. That position disappeared with the introduction of the universal franchise and is now not valid at the national level, far less at the local level.

Sovereignty vesting in the People, means all of the People equally, so the democratic process is necessarily colour-blind. This principle must apply to democracy at both the national and the local level. The alternative is apartheid, and we all know that did not have a happy ending.
