#### Submission

We are Kevin and Glenis McDonald of 62 Airport Drive Property ID 7098. This submission relates to the realignment of Airport Drive, the road connecting Airport Drive to Area Q, and specifically the road to Area R which will effect us in the future.

We have lived on this road for over 30 years. During this time we have seen the huge growth around us, and the increasing number of vehicles on the road. As we head into New Plymouth most days, we are concerned for our safety and how hazardous the right turn onto SH 3 has become.

Therefore, we are in full support and approve of the proposed plan/design of the realignment of Airport Drive, and the Future Urban Development of Area R. And the sooner the better.

We are also in full support of the proposed development of the Central Football site for the future of Taranaki. We feel the proposed plan of the road, and the cycle and walking pathway alongside it leading to Area R, would greatly enhance what they are proposing to do.

Considering the proposed road connecting Area R through Central Football land runs along the southern boundary of our land, we feel there would be great advantage to complete all the proposed roading/works within the same construction period. Doing it all in one timeframe, disruption to the residents effected, and the effects on the environment would be as minimal as possible. The visual enhancement of Airport Drive and the roads running off it, would also be developed at the same time. As Airport Drive is the gateway to New Plymouth, we feel this is important.

This road to Area R would also give our eastern boundary neighbour's Mr & Mrs Miller, a safe and linkable access to SH 3, and we are in full support of all they are proposing to council.

As we have cattle grazing in our southern back paddocks, they would be adjacent to any works of the road to Area R. We would need to make sure they are safe and secure at all times. Therefore, we would appreciate being fully informed as the final design/decisions are made following the review of the submissions.

We look forward to safer access to Airport Drive and our home, and the future development of Area R. We are happy to work with the New Plymouth District council in any way we can, to make all of this happen as seamless as possible.
